

## HOW TO MAKE A BEQUEST TO PRESBYTERIAN SUPPORT SOUTH CANTERBURY

- In making or revising your Will, it is important that you consult with your legal adviser.
- The appropriate wording to consider, and to show your adviser is:

I give the sum of \_\_\_\_\_ dollars (\$\_\_\_\_\_)

Or description of assets

Or the residue (or a defined portion or percentage) Of my estate...

free of all duties to Presbyterian Support Services (South Canterbury) Incorporated for its general purposes. I direct that a receipt given on behalf of the Society will be a complete discharge to my trustee for the legacy.

It is recommended that everyone has an up to date will that reflects their current wishes. When reviewing your will we ask that you consider providing a gift for PSSC. - You may leave a gift from the residue of your estate. This means that after specified gifts for your family, friends and other you wish to recognise, you can leave part or all that is left from your estate - the residue - to PSSC
- You can leave a percentage of your estate or a specified cash amount to PSSC
- You can directly gift land or property
- You can mention PSSC as a beneficiary of your life insurance policy
- You can leave a bequest to a specific PSSC activity
